

New entrants are encouraged to make several school visits before their 5th birthday to help make the transition from preschool to school as smooth, happy and positive as possible. Home Zone



DORIE SCHOOL (#3329) Enrolment Scheme Description

Commenced 01 January 2022

Home Zone

All students who live within the home zone described below shall be eligible to enrol at the school.

Starting from the intersection of Gardiners Road and Action Road,

- North East to the Rakaia River
- South East along the south west bank of the Rakaia River to the ocean
- South West along the coastline to Winters Road
- North West along Winters Road to Denshires Road North
- North East along Denshires Road North to Christys Road
- East along Christys Road to Pendarves Rakaia Road
- North along Pendarves Rakaia Road to Gardiners Road
- North East along Gardiners Road to Action Road

Addresses on both sides of boundary roads are considered in-zone unless specified otherwise.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date that will be published by public notice in a medium appropriate to the area served by the school. This will enable the board to assess the number of places that can be made available to students who live outside the home zone.

Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

Out of Zone Enrolments

Applications for enrolments will be processed in the order of priority specified in the Education and Training Act 2020.

Before the application deadline associated with each pre-enrolment period, a Board must, by public notice in a medium appropriate to the area served by the school:

- confirm the already advertised dates for the receipt of applications and for the holding of the ballot.
- state the likely number of out of zone places that remain available.

If there are more applicants in any priority group than there are places available, selection within the priority group will be by ballot conducted in accordance with <u>instructions by the Secretary</u>, under Schedule 20, Clause 3 (1) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants may be required to give proof of address or sibling relationship.

The guidelines for development and operation of enrolment schemes are issued under Schedule 20, Clause 3 (3) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Proof of residence within the home zone will be required through a copy of an amenities account (e.g. rates, power or telephone account).

If at all possible, we would appreciate at least one weeks notification that you intend to enrol your child at Dorie Primary School so that preparations can be made to receive your child.

Notification can be made by phoning the school office (3020862), or completing our online enrolment form.

New entrants are encouraged to make several school visits before their 5th birthday to help make the transition from preschool to school as smooth, happy and positive as possible. More information on our New Entrant Transition Process can be found below.

Out of Zone Enrolments

Each year the Board of Trustees will determine if there are a limited number of places likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolments will be processed in the following order of priority:

- **First Priority** This priority is not applicable at this school because the school does not run a special programme approved by the Secretary for Education.
- Second Priority will be given to applicants who are siblings of current students.
- Third Priority will be given to applicants who are siblings of former students.
- Fourth Priority will be given to any applicant who is a child of a former student of the school.
- **Fifth Priority** will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.
- Sixth Priority will be given to all other applicants.

If there are more applicants in any priority group than there are places available, selection within the priority group will be by ballot conducted in accordance with <u>instructions by the Secretary</u>, under <u>Schedule 20</u>, <u>Clause 3 (1)</u> of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants may be required to give proof of address or sibling relationship.
